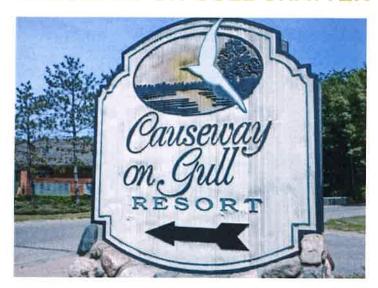

If you wish to be involved with your resort you can become a candidate for service to Causeway on Gull – this includes Incumbent Board and Ad Hoc Members. Your name will be included on a Directed Proxy/Ballot. Please provide written notice to the association at the contact information below. Candidate Bio information must be received by 5:00PM, September 20th, 2024, your name will be included on the Meeting Ballot and on a Directed Proxy Form which will be mailed to all owners the week of October 9, 2024.

Owners are encouraged to apply for a Board of Directors or the Ad-Hoc Committee member position by sending in a Candidate Bio Form limited to one sheet of 8X10 paper to include Date, Name, Week and Unit Owned, About you, Qualifying Experience, and Objective skills to be of service.

You can select to be on either committee, not both. You do not need to be a local resident in order to serve on the board, however, in person attendance at the board meetings is relevant and requested. We are looking for analytical people to help move Causeway forward while working within the budget we have. People with accounting, IT, law, creative, and innovative ideas, most importantly need to be a collaborator. You must be willing to dedicate your time, attend meetings, and give input. Please plan a minimum of one to two hours a week. Board Members serve a term of three years, Ad Hoc Members serve a term of one year.

Included with the Annual Meeting Announcement Invitation this year we will introduce a Directed Proxy Ballot. You will be able to select your choice of three candidates for Board Members and three Ad Hoc Members. Any current Board Member whose term has expired will apply as an incumbent if they choose to run again. The top three vote getters in each category will be elected.

Grounds Committee

Jim Leukum our Grounds Manager is reporting that carpet has been installed in all the twin home units, 1-52. A big thank you to all the people involved in this project. The 6 plex units up on the hill 53-58 will be completed starting in the slow season this Fall. We have added additional pool deck furniture, replacing decking boards that were the originals from when the outdoor pool was constructed. Installed gutters on units, replace sliding doors, replaced nonworking screens along with many appliances that need to be replaced. Our next big replacement project we are looking at will be furniture. Slowly but surely work is progressing. There are still issues with roofs and tiles in bathrooms that will be tackled as funds become available.
